Application for OCP California Tax Exempt Status

About this time last year, I applied for OCP Tax Exempt status with the California Franchise Tax Board. Hearing nothing recently, a phone call was made to FTB. They advised our application was coming up for review as the lead time is running 11 months. The agent took a look at our application and found the form I used would subject us to back taxes of \$800 / per year. She recommended I withdraw the application via a letter in writing, re-file using the proper form, submit tax filings for the past 5 years, and include a copy of our by-laws with the filing.

All of this was completed on 03/25/2026. I assume this will restart the 11-month waiting period until the application is reviewed. I used my Santa Ana address for communication purposes eliminating the concern if Glen would forward communication from the FTB.
